Technical Education - In 2023, we celebrated 103 new graduates from our technology and life skills programs. These programs have demonstrated remarkable success in uplifting justice-involved individuals and their families, particularly our youth program, with 71 youth participants served during 2023. One of the most impressive indicators of success is our participants' incredibly low (2%) recidivism rate compared to the national average (44%).

Our proudest achievements remain the certification of students as Full Stack Developers through our coding boot camps, conducted in correctional facilities and communities, which is successfully placing graduates in well-paying jobs in the rapidly growing tech industry,

On-the-Job Training - Banyan Labs is an IT solutions provider offering high quality IT services while aiding the effort to reduce recidivism and empower justice-involved individuals to succeed. Banyan Labs hires graduates from Persevere's technical training program as certified full stack developers. By supporting their training and employment in the tech industry, Banyan Labs focuses on client value and associate growth.

For those who are incarcerated, most are hired by Banyan Labs prior to their release from prison and they come to work within 72 hours of release. When these graduates are assigned to Banyan Labs' projects, they work with mentors to begin contributing immediately while learning
